

After considering all material facts, NHIDCL is of the considered view that you the above named addresses be banned and are, therefore, hereby banned for a period of 5 years from the date of issue of this letter from prequalification, participation or bidding for future projects of /or to be undertaken by NHIDCL, either directly in your name or indirectly in any other name or in association with any other person/entity with which you may choose to carry out your business. Apart from this, suitable action as per IPC would also be initiated.
