
1. In continuation of the Public Notices referred to above, the following instructions are issued for the information of all candidates appearing in the Stage-I Computer Based Test (CBT) on 29th June 2026:
 - (a) Eligible candidates seeking reimbursement of Travelling Allowance (TA) are required to submit their claims online through the prescribed Google Form.
 - (b) The link for submission of online TA claims shall be made available on the NHIDCL website on **29.06.2026**.
 - (c) Candidates may submit their TA claims by accessing the Google Form available on the NHIDCL website during the period from **29.06.2026 to 04.07.2026 (up to 05:00 PM)**.
 - (d) Candidates are advised to fill in all required details carefully and upload the prescribed supporting documents while submitting the online TA claim.
 - (e) No manual or offline submission of TA claims shall be accepted. Candidates are, therefore, advised not to send any hard copies of their claims or supporting documents to NHIDCL.
 - (f) It may be noted that reimbursement of TA shall be admissible only to those candidates who have travelled a distance of **more than 100 kilometres** from their place of residence to the examination centre, subject to fulfilment of the prescribed eligibility conditions and submission of valid supporting documents.
 - (g) TA claims received after the stipulated deadline or submitted without the requisite supporting documents may not be considered for reimbursement.

2. General Instructions

- (a) All correspondence/queries related to Recruitment to E4 to E7 grade shall be made at direct.recruitment@nhidcl.com. No other mode of correspondence shall

be valid. Candidates are advised to keep visiting NHIDCL website for further information.
