

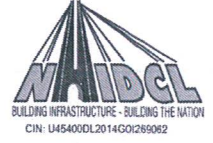

Whereas, NHIDCL vide its Hiring Notice No. 05/2025 dated 23.12.2025 invited applications for engagement of Associates under the State Specific Graduate Scheme for various States.

2. And whereas, NHIDCL vide its Public Notice 261901/1356 dated 06.05.2026 published interview scheduled of eligible candidates for engagement as Associates under SSGS Scheme in respect of State of Assam and West Bengal.

3. And whereas, interviews of provisionally eligible candidates were conducted through Video Conferencing on 14.05.2026 by the duly constituted internal Selection Committees.

4. And whereas, the selection process was completed and Competent Authority, based on the recommendations of Selection Committees, has approved engagement of Associates under State Specific Graduate Scheme for a fixed period of 02 years.

5. Now, NHIDCL publishes the Provisional List of selected candidates, subject to verification of documents, for each State/ Regional Office as given at **Annexure - I**.

6. Accordingly, the candidates mentioned in the provisional list at Annexure -I are required to report to the respective Regional Offices within 15 days of publication of this Public Notice. If a candidate, fails to report within the stipulated period, and no extension for joining is granted by the Competent Authority, it shall be presumed that the candidate is not interested in the engagement. In such cases, the provisional offer/selection shall stand cancelled without any further notice.

7. The engagement of Associates shall be purely on contractual basis and shall not confer any right or claim for regular appointment, absorption or continuation in NHIDCL.

8. Selected candidates shall be required to sign a contract before joining at the respective Regional Offices.

9. The engagement is subject to verification of eligibility conditions, Candidates may be asked for Detailed Document Verification (DV) of original documents/background verification and Police verification before joining, and all conditions prescribed in the Hiring Notice and EP/YP & PoE scheme of NHIDCL.

10. NHIDCL reserves the right to cancel the candidature at any stage if any information furnished by the candidate is found to be false, incorrect, or incomplete.
