The Ministry of Road Transport & Highways through EXECUTIVE DIRECTOR (P) NHIDCL, RO - AIZAWL, MIZORAM, (the “Authority”) is engaged in the development of National Highways and as part of this endeavor, “the Authority” has decided to **invite Single Percentage Rate Bids** through e-tendering from experienced firms/organizations for maintenance works and activities for the following sections of the National Highway as mentioned below at Table- 1

2. The preliminary requirements (detailed requirements are given in the Bid Documents)of bidding firm / contractor for above work are mentioned as under:-

Any conditional evidence of deployment of above equipment or inadequate proof as required for any of the equipment shall make the bid non-responsive and financial bid shall not be opened.</p>

3. The Scope of Work includes the routine maintenance of all the assets and facilities existing within Right of Way (ROW) on the above mentioned section including maintenance of carriageway, shoulders, median, bridges, culverts, drains, footpaths, road signage, plantation etc., and carrying out other works as specified in the bid documents.

4. To participate in the e-Bid submission, it is mandatory for the Bidders to get registered their firm with e-procurement portal <https://eprocure.gov.in/e-procure/app> to have user ID password which has to be obtained free of cost. Following may kindly be noted:

- (a) Registration with e-procurement portal should be valid at least up to the date of submission of BID.
- (b) BIDs can be submitted only during the validity of registration.

The Bidders shall update their project and other details on the portal on a regular basis and apply to the tenders via the portal. The complete BID document can be viewed / downloaded from official portal of the CPPP website (eprocure.gov.in/e-procure/app) from 17/06/2026 to 16/07/2026 upto 14.00 Hrs IST. The amendments/ clarifications to the Bid Document, if any, will be uploaded on the above website.

The bidder is required to submit, along with its BID, **Bid Security/ Earnest Money** for a particular job as per mentioned above in the form of Bank Guarantee or in any other form as allowed vide Ministry's Latest Circular No. NH-24028/14/2014-H (Voll) (E-134863) dated 31.05.2023. **(See Clause 16 of Section-2)**

The bidder is required to submit, along with its BID, the cost of BID/RFP document, i.e. Rs. 10000.00+18% GST/- (Rupees Ten thousand + 18% GST only) payment through RTGS/NEFT to be submitted with hard copy of the bid. Failure to submit either of the above will result in rejection of bids.

5. The Bid should be submitted online in the prescribed form at given on the website. No other mode of submission is acceptable.

6. The authorized signatory holding Power of Attorney shall only be the Digital Signatory. In case authorized signatory holding Power of Attorney and Digital Signatory are not the same, the bid shall be considered non-responsive.

7. The last date for online submission of the Bid is 16/07/2026 up to 14.00 hrs (as mentioned on the e-portal only) ("Bid Due Date"). Bidder must submit its Financial Bid and Technical Bid on CPPP e-procurement portal within the above deadline. However, Online receipt of Document Fee, Power of Attorney and Bid Security etc. shall be submitted physically by the Bidder on or before 16/07/2026(at 14.00 hours IST) at the Office of EXECUTIVE DIRECTOR (P) NHIDCL, RO -AIZAWL, MIZORAM/ Regional Office, Aizawl, Mizoram. The bids would be opened on 17/07/2026 after 14:00 hrs online at O/o The EXECUTIVE DIRECTOR (P) NHIDCL RO -Aizawl, Tuikhuahtlang Aizawl, representatives of the bidders (maximum of two) who choose to attend, may attend the online opening of the bids at O/o The EXECUTIVE DIRECTOR (P), NHIDCL RO -Aizawl, Tuikhuahtlang, Aizawl, on the date and time as mentioned above. However, such representatives shall be allowed to attend the opening of the bids only if they produce letter of authority on the letterhead of the bidder, at the time of opening of bids as mentioned above. A Bidder is required to submit, along with its BID, a BID Security Declaration (The bid security declaration shall be submitted as per clause 2.2 of this RFP).

8. The period of validity of bid is 90 days from the deadline of submission of bid.

9. This NIT is published based on estimated amount Submitted to Ministry of Road Transport & Highways. However, Finalization of bids shall be subject to Sanction of the estimates from the Ministry and NIT value(s) & Quantities may change accordingly for which no claim will be entertained.
