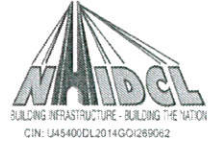

Public Notice (TA claim)

Subject:- Conduct of Stage-II Specific Written Test and Instructions regarding Travelling Allowance (TA) Reimbursement for candidates appearing for Technical Cadre Posts (E-4 to E-7) under Recruitment Notice No. 04/2025.

1. Whereas, NHIDCL vide Recruitment Notice No. 04/2025 dated 09.12.2025 invited applications from eligible, experience and qualified candidates for various posts in E4 to E7 Grades in its Technical Cadre
2. And whereas, vide its Public Notice No. 260733/2425 dated 24.07.2026 notified dates and other instructions for Stage-II Specific Written Test for recruitment notification vide Notice No. 04/2025 dated 09.12.2025.
3. Now whereas, NHIDCL further informs that candidates appearing in the Stage-II Specific Written Test at Delhi/NCR shall be eligible for reimbursement of Travelling Allowance (TA) as per the following terms and conditions:

- a. **Eligibility for Reimbursement:** Candidates whose distance from their place of residence, to the Examination Centre exceeds 100 kilometers shall be eligible for reimbursement of travelling expenses for onward and return journeys.
- b. **Extent of Reimbursement:** Reimbursement shall be limited to the following:
 - (i) AC-II Tier rail fare by the shortest route; or
 - (ii) Bus fare equivalent to AC-II Tier rail fare by the shortest route, wherever rail connectivity is not available.

- c. **Condition for Reimbursement:** Reimbursement shall be admissible only upon submission of proof of travel/tickets for the onward and return journeys.
- d. **Restriction on Reimbursement:** Reimbursement shall be restricted strictly to AC-II Tier rail fare by the shortest route, irrespective of the mode of travel actually undertaken.
- e. **Cases Where Reimbursement is Not Admissible:** No TA reimbursement shall be admissible where the distance between the candidate's declared place of residence/office and the Examination Centre is less than 100 kilometers.
- f. **General** The decision of NHIDCL with regard to admissibility and extent of reimbursement shall be final and binding.
4. Further all candidates are advised to keep referring to NHIDCL website for further information on Examination Centre and Admit Card.
5. This notification is issued with the approval of the Competent Authority of NHIDCL.
