### Public Notice (TA claim)

**Subject:** Conduct of Stage-I Eligibility Test and Instructions regarding Travelling Allowance (TA) Reimbursement for candidates appearing for Deputy Manager (Finance & Accounts) Posts at E-2 Grade under Recruitment Notice No. 02/2026.

1. Whereas, NHIDCL vide Recruitment Notice No. 02/2026 dated 16.02.2026 invited applications from eligible, and qualified candidates for various posts in E-2 Grade in its Finance & Accounts Cadre
2. And whereas, vide its Public Notice No. 263718/2691 dated 13.08.2026 notified date and other instructions for of Stage-I Eligibility Test for recruitment notification vide Notice No. 02/2026 dated 16.02.2026.
3. Now whereas, NHIDCL further informs that candidates appearing in the Stage-I Eligibility Test at Delhi/NCR shall be eligible for reimbursement of Travelling Allowance (TA) as per the following terms and conditions:

a. **Eligibility for Reimbursement:** Candidates whose distance from their place of residence, to the Examination Centre exceeds 100 kilometres shall be eligible for reimbursement of travelling expenses for onward and return journeys.

b. **Extent of Reimbursement:** Reimbursement shall be limited to the following:

- (i) Non- AC Sleeper class (SL) rail fare by the shortest route;  
or
- (ii) Bus fare equivalent to Non-AC Sleeper class rail fare by the shortest route, wherever rail connectivity is not available.

c. **Condition for Reimbursement:** Reimbursement shall be admissible only upon submission of proof of travel/tickets for the onward and return journeys.

d. **Restriction on Reimbursement:** Reimbursement shall be restricted strictly to Non-AC Sleeper class rail fare by the shortest route, irrespective of the mode of travel actually undertaken.

e .Cases Where Reimbursement is Not Admissible: No TA reimbursement shall be admissible where the distance between the candidate's declared place of residence/office and the Examination Centre is less than 100 kilometres.

f. **Procedure of claim:** The online link for submission of TA reimbursement claims shall remain available on the NHIDCL website from 24<sup>th</sup> August, 2026 (05.00 PM) to 28th August, 2026 (05.00 PM). Candidates are advised to submit their TA claims within the stipulated period along with the requisite supporting documents, as prescribed. TA claims submitted by any other means shall not be accepted.

g. **General** The decision of NHIDCL with regard to admissibility and extent of reimbursement shall be final and binding.

4. Candidates are advised to regularly visit the NHIDCL website and their registered email id for further updates relating to the examination center and admit card.
