Public Notice

Subject: Conduct of Stage-I (Eligibility Test) and Related Instructions to candidates for Recruitment to the Posts of Deputy Manager (Finance & Accounts) at E2 grade under the Recruitment Notice no. 02/2026; reg,

1. In reference to the recruitment notification 02/2026 issued for the posts to the **Posts of Dy Manager (Finance and Accounts) at E2 grade under the Recruitment Notice no. 02/2026**, the following instructions are hereby issued for information of all candidates appearing in Stage-1 Eligibility Test:

a. Examination Pattern

- i. The syllabus for Stage-I (Eligibility Test) for the posts of Deputy Manager (Finance and Accounts) shall be as per Public Notice dated 17.07.2026 and Corrigendum issued on 10.08.2026 available on NHIDCL website.
- ii. The examination shall consist of 100 multiple-choice objective-type questions and shall be Computer Based Test.
- iii. The question paper shall be bilingual, i.e., in English and Hindi.
- iv. Total duration of the examination shall be 120 minutes.
- v. Additional compensatory time of 20 minutes per hour shall be allowed to PwBD candidates, as applicable.
- vi. There shall be negative marking for incorrect answers.

b. Examination Centres

- i. The Stage-I (Eligibility Test) for the Posts of Deputy Manager (Finance & Accounts) and shall be conducted at examination centres located in Delhi/NCR on 24.08.2026 (Monday) in a single session.
- ii. Admit Cards shall be available for download on NHIDCL website 03 to 05 days prior to the date of examination.
- iii. The exact address, & timings of the Examination Centre shall be intimated to the applicants through the Admit Card.
- iv. No request for change of examination centre or date shall be entertained under any circumstances.

c. Eligibility of candidates for Stage-1 (Eligibility Test)

- i. All candidates who have applied for the posts advertised vide Recruitment Notice No. 02/2026 dated 16.02.2026 are required to appear in the Stage-1 (Eligibility Test).
- ii. The eligibility criteria for the post of Deputy Manager (Finance & Accounts) is as given in the Recruitment Notice. The Candidates are required to satisfy themselves with respect to eligibility conditions.
- iii. The NHIDCL shall check and verify documents at the time of Document Verification stage, for which a separate notice will be issued after Stage-2 written test. In case any candidate does not have or produce the required documents such as those related to essential qualifications, age and any other criteria in recruitment notice, the candidature of such candidate shall be rejected at that stage.

d. General Instructions

- i. Candidates are advised to carefully read and strictly adhere to the important instructions mentioned in the Admit Card.
- ii. Email ID for complete Recruitment process is direct.recruitment@nhidcl.com. All correspondence/queries related to

Recruitment to Deputy Manager (Finance & Accounts) be made at above mentioned email id. No other mode of correspondence shall be valid.

e. Objection Management & email ID

i. The objection management link shall be activated one to two days after the conduct of Stage – I (Eligibility Test). The objection management link shall remain active for three days.

ii. No objections or examination-related queries pertaining to Stage-I (Eligibility Test) shall be entertained thereafter.

f. Malpractice and disciplinary provisions

Any candidate found indulging in any form of malpractice, misconduct, impersonation, use of unfair means, possession/use of prohibited electronic devices/materials, or violation of examination instructions during the Stage-I (Eligibility Test) shall be liable for disqualification from the examination and debarment from future recruitments of NHIDCL.

2. All corrigendum/Addendum relating to the present recruitment process shall be published on NHIDCL website.

3. This is issued with the approval of Competent Authority of NHIDCL.
