Detail reason for Non-responsiveness**1) M/s N.I Enterprise**

It is to mentioned that the as per **Clause 4.6 of RFP**, “Bid Capacity: - Bidders who inter alia meet the minimum qualification criteria will be qualified only if their available BID capacity is more than the total BID value”. However, the bid capacity of **M/s N.I. Enterprise** calculated from the maximum value of civil work in last 5 years does not meet the minimum criteria for eligibility.

Calculated as BID capacity = $(A*N*2.5 - B + C)$ (in crore): $13.96*0.25*2.5-0+0 = 8.73$ Cr, taking into account maximum value of civil engineering work for FY 2023-24 by updating the price factor.

It is also pertinent to mention that as per **Clause 4.4 (b) of RFP** “Satisfactorily completed (not less than 90% of Contract value), as a **prime contractor (or as a nominated subcontractor**, provided further that all other qualification criteria are satisfied) **similar works** during last five years ending last day of month previous to the one in which bids are invited, Experience in successfully completing or substantially completing at least one contract of road i.e. State Highway, National Highway with similar or higher work specification of at least 20% of value of proposed Contract within the last five years.

M/s N.I Enterprises has submitted work experience certificate not issued by Competent Authority of NHIDCL.
