**NOTICE INVITING TENDER (NIT)**

1. NHIDCL propose to invite Tender for the Consultancy Services for preparation of Detailed Project Report and for Pre-Construction activities towards Construction of 4-lane Tunnel Connectivity across River Brahmaputra between Gohpur (on NH-15) and Numaligarh (on NH-715) in the State of Assam. (as per **Annexure-I**).
2. Proposal are hereby invited from eligible Consultants for preparation of the Detailed Project Report for the proposed Tunnel across the River Brahmaputra between Gohpur and Numaligarh in the State of Assam. The Consultant is required to review, do value engineering based on the available site/field data provided and to suggest any additional tests if required and accordingly propose the methodology and most competitive cost taking in to consideration the latest technology and the proposed timeline required for construction of the proposed 4-lane Tunnel Connectivity across River Brahmaputra. The Letter of Invitation (LOI) and Terms of Reference (ToR) including Request for Proposal (RFP) is available online on e-tender portal of <https://eprocure.gov.in>. The document can also be downloaded from NHIDCL Website (<https://nhidcl.com/current-tenders/>). Cost of the Document in the form of a Non-refundable document fee of Rs. 5,900 (Rupees Five Thousand Nine Hundred only which is inclusive of GST) into the bank account of the NHIDCL through the online facility provided by the IndusInd Bank (For details refer at Clause 3.1.1 (iv) of the LOI).
3. **The Authority had conducted feasibility studies for this tunnel through an Expert Consultant. The reports & details are available for reference under Part 2 (Reference Documents). The Bidders are advised to take into consideration the available reports/survey reports while defining the scope of work to be done by them and the financial proposal. It may be noted that the authority does not indemnify the consultant for correctness of these reports. Bidders are hereby advised to conduct sample check for ascertaining correctness.**
4. The RFP has also been uploaded on "INFRACON" ([www.infracon.nic.in](http://www.infracon.nic.in)). As such before submitting the proposal the consultant shall mandatorily register and enlist themselves (the firm and all key personnel), on the MoRTH portal "INFRACON" and furnish registration details along with its Technical Proposal. A copy of INFRACON Operation Procedure is also enclosed for bidder's reference.
5. **All bidders registered on INFRACON shall form a Team on INFRACON and which would be assigned unique INFRACON Team ID. Bidders while submitting the proposal shall quote the INFRACON Team ID. If CV not available then atleast upload for Team Formation & make it available.**
6. The timeline proposed for preparation and submission of the DPR including the other field related works to be completed within six (6) months. For details refer RFP,
