1. The RFP for the above subject work was invited with bid due date on 23.03.2017 till 1630hrs. In all, **Five bids** were received from the following bidders.

2. The technical bid for the project was opened on 24.03.2017 at 1700 hrs on CPP portal and INFRACON portal. Manual evaluation is carried out from the CVs of the firm & Key Personnel's uploaded data on INFRACON Portal.

3. It was brought to the notice of Committee that M/s L N Malviya Infra Projects Pvt Ltd eligible for financial opening were debarred from NHAI for a period of 3 years from 28.03.2017. Though the Consultant has submitted the bid on 23.03.2017, However as they have been debarred by NHAI during the Technical Evaluation, Hence the Committee decided that the bid of M/s L N Malviya Infra Projects Pvt Ltd be declared as Non-Responsive. Therefore Four bidders are eligible for Technical Evaluation.

4. As per clause 11 of RFP, the average annual turnover for three Financial Year should be equal to or more than **25.06 Crore** for qualification for Technical Evaluation. Two firms have submitted their annual turnover online at INFRACON for the year 2013-14, 2014-15 & 2015-16 and M/s Voyants Solutions Pvt Ltd & M/s Yongma Engineering Co. Ltd. in Association with M/s Sterling Indo Tech Consultants Pvt Ltd. have submitted Annual Turnover online at INFRACON for the year 2014-15, 2013-14, 2012-13. Average Annual Turnover of M/s Voyants Solutions Pvt Ltd. & M/s Yongma Engineering Co. Ltd. in Association with M/s Sterling Indo Tech Consultants Pvt Ltd have been calculated in worst scenario considering Turnover of 2015-16 as zero. The turnover submitted by the firm is as below.

8. Two key personnel of **M/s Voyants Solutions Pvt Ltd** i.e. **Bridge Design Specialist and Highway Design Specialist** could not score the minimum qualifying marks of 75%. Further it is noted that the all the above two Key Personnel have not filled their CV matching input filed despite of good relevant experiences in NHAI projects.

9. Two key personnel of **M/s Yongma Engineering Co. Ltd. in Association with M/s Sterling Indo Tech Consultants Pvt Ltd.** i.e. **Sr. Contract Specialist and Bridge Design Specialist** could not score the minimum qualifying marks of 75%. Further it is noted that the **Bridge Design Specialist** Key Personnel has not filled CV matching input filed despite of good relevant experiences in projects.

10. All the Key personnel's of **M/s Highway Engineering Consultant in Association with Agnitio Infrastructure Project Pvt. Ltd & M/s Chaitanya Projects Consultancy Pvt. Ltd. (JV)** score more than 75% marks.

11. One Key personnel's of **M/s Feedback Infra Pvt Ltd. in Association with M/s A&A Consulting Engineers** i.e. CV of **Resident Engineer cum Pavement Specialist & Road Safety Expert** educational Details on INFRAOCN Portal was not updated therefore the marks has been given "zero" as per Clause 3.4(iv)(f).

12. In view of above, the committee recommends for opening of financial bids of following bidders by giving 7 days time and to communicate the Technically responsive bidders their Technical score for Clarification/Representation if any by uploading on website.
