

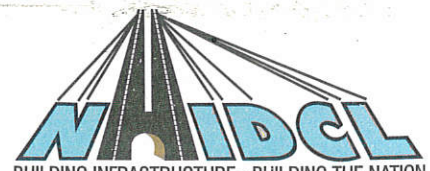

Kindly provide the Board resolution or POA which establish that the executor has power to authorize other person for signing of Bid.
2	Annex-VI to Appendix-1A (Bid capacity)	The Statement given by Statutory Auditor of bidder for certifying Value of B submitted on page 696 for Lead Member and 764 for other member do not certify the words "anticipated value of work to be completed in the period of construction of the project for which bid is invited" which are required as per Format of Annex-VI to Appendix-1A. Kindly provide the correct certificate duly incorporating the required statement by Statutory Auditor.
