NHIDCL has been assigned the work of Feasibility study, Preparation of Detailed Project Report and providing pre-construction services for “Consultancy Service for Preparation of Feasibility Study and Detailed Project Report for development of existing road to 4-Lane with paved shoulder of Barapani - Shillong Road (NH-06) from Km 61+800 to Km 78+000 alongwith bridge at Umiam Dam in Meghalaya . (as per Annexure-I).
2. Proposals are hereby invited from eligible Consultants for preparation of Detailed Project Report of and providing pre-construction services for “Consultancy Service for Preparation of Feasibility Study and Detailed Project Report for development of existing road to 4-Lane with paved shoulder of Barapani - Shillong Road (NH-06) from Km 61+800 to Km 78+000 alongwith bridge at Umiam Dam in Meghalaya ”. The Letter of Invitation (LOI) and Terms of Reference (ToR) including Request for Proposal (RFP) is available online on e-tender portal of <https://eprocure.gov.in>.
