1. The RFP for subject work was invited with bid date on 23.03.2017 and two bids were received. Accordingly the Bid was valid till 21.07.2017 hence both responsive bidders were asked for extension of bid validity by two months vide this office letter dated 18.07.2017. In response M/s L N Malviya Infra Projects Pvt Ltd and M/s Highway Engineering Consultant in association with Agnitio Infrastructure Projects Pvt Ltd has extended the validity of their bids upto 21.09.2017 & 21.09.2017 respectively.

2. Consequent upon Approval of Competent Authority, the technical score of the bidders were uploaded on the website to submit the clarification/representation if any by the consultant on or before 23.08.2017(11:00 hrs). The uploaded scores of respective consultants are tabulated below.

In response, M/s Highway Engineering Consultant in association with Agnitio Infrastructure Projects Pvt Ltd has represented against the published scores claiming 86.125 marks against evaluated 82.62 marks. M/s L N Malviya Infra Projects Pvt Ltd has also represented against the published scores and claimed 92.83 marks against evaluated 91.81 marks.

Earlier only 4 projects were evaluated by INFRACON Portal and 5 <sup>th</sup> Project i.e. "Project Management Consultancy of four laning of Nagpur to Hyderabad section of NH-7 in the state of Maharashtra." was not evaluated as nature of assignment shown on INFRACON Portal was other works. At the time of representation, Consultant has claimed 24.75 marks out of 25 marks. Hence the projects have been examined during re-evaluation and it is observed that the project is for Construction Supervision which was also verified on INFRACON Portal and found in order accordingly mark on account of Construction Supervision is amended to 16marks and thus total marks amended to 83.62marks. | 2 | M/s L N Malviya Infra Projects Pvt Ltd | Consultant has represented that technical score for the team is about 92.83 marks instead of 91.81 marks. | Representation from Consultant has been examined during re evaluation, it is observed that Consultant has proposed Mr. KARETI SREE RAMAKANTH as a Resident Engineer cum pavement specialist & road safety expert and his CV is blocked on INFRACON Portal. Hence his marks are now (in re-evaluation) considered as zero marks against earlier score of 13.5 marks. This CV was live at the time of evaluation however blocked subsequently which is revealed during the re-evaluation requested by the Consultant. 6.
