Terms & Conditions

A. Technical

1. The Stone Boulders put for sale shall be disposed off in "AS IS WHERE IS" basis. No complaints whatsoever will be entertained after the bid is made and it will be expressly understood that the bidder has fully satisfied himself regarding the quality, quantity and condition of the available material before bidding.
2. Bidder will be considered for evaluation only if bidding fee, EMD in original is deposited within prescribed time limit in the office of Executive Director (P), National Highways & Infrastructure Development Corporation Ltd. Regional Office- M/s Agni Shanti Buildtech Pvt Ltd., 2nd Floor, Agnishanti Business Park, Opp.- AGP Office, GNB road, Ambari, Guwahati-781001, Assam. Further all other documents mentioned in list of documents should also be uploaded.
3. Original Documents if any asked by the Executive Director (P), NHIDCL, RO-Guwahati should be produced immediately by the bidder.
4. No bidder shall be exempted from payment of EMD and EMD Exemption given by other Department will not be accepted. Offer submitted without EMD will be rejected.

5. ACCEPTANCE OF BIDDING:

Tender will be accepted as per conditions given in Para A2 above. However acceptance of bids will rest with the authority, who reserves the right to reject any or all bids without assigning any reasons. The acceptance of highest bidder shall be intimated to the bidder by letter. Such information shall be deemed to be an intimation of Acceptance of Contract (AOC). The bidder whose offer is accepted shall have to complete the contract within 30 days from the issue of Work order to do so and shall abide by all the rules and regulations and special conditions enumerated therein or attached herewith.

6. VALIDITY:

The offer shall remain valid for a period 90 (Ninety) days from the date of opening of online Bid.

B. Taxes

1. All duties, taxes (except service tax), royalties and other levies payable by the Contractor under the Contract, or for any other cause, shall be included in the unit rates, and total Bid price quoted by the Bidders.

C. Payment Terms.

1. 50% of the total payment of boulders will be deposited by the bidder within 07 days time from date of Letter of Acceptance (LOA) issued by NHIDCL to the Executive Director (P), National Highways & Infrastructures Development Corporation Limited, Regional Office- M/s Agni Shanti Buildtech Pvt Ltd., 2nd Floor, Agnishanti Business Park, Opp.- AGP Office, GNB road, Ambari, Guwahati-781001 in the Form of Demand Draft/RTGS and balance amount within 15 days from date of issue of work order.

D. General

2. The Complete Bid Document can be downloaded with effect from **08/06/2017** and will be open upto **29/06/2017 upto 1400 Hrs** at the NHIDCL e-tendering portal free of cost. To participate for bidding, bidders have to pay non-refundable document fee of Rs. 1000/- in the form of DD or Banker's cheque drawn on any schedule bank in India in favour of "Executive Director (P), National Highways & Infrastructure Development Corporation Ltd. Representatives of the bidders (maximum of two) who choose to attend may attend the online opening of the bids at NHIDCL, Regional Office, Guwahati the date & time as mentioned above. However, such representatives shall be allowed to attend the opening of the bids only if they produce letter of authority on the letter head of the bidder, at the time of opening of bids as mentioned above.

6. The bidder has to submit the bid document online well in advance before prescribed time.
