However, such certificates are not exactly as per the required format of para 14 of Annex-IV to Appendix-1A as the words <i>"It is certified that Bidder received payments from its Clients for Construction Works executed by them or work executed and certified by the Engineer-in-charge/Independent Engineer/Authority's Engineer"</i> are not as per required format. <i>Kindly provide the Certificates by Statutory Auditor which should be as verbatim with the format of para 14 of Annex-IV to Appendix-1A along with the certificates issued by the "Engineer-in-charge/Independent Engineer/Authority's Engineer".</i>
2.	Test of Responsiveness	Appendix II Bank Guarantee	In Bank Guarantee submitted by the Bidder, point 15 is not mentioned. <i>Kindly clarify and provide the amendment while including the aforesaid missing clause.</i>
3.	Bid Capacity	Annex VI	The Statement given by Statutory Auditor of bidder for certifying Value of B submitted do not certify the words <i>"anticipated value of work to be completed in the period of construction of the project for which bid is invited"</i> which are required as per Format of Annex-VI to Appendix-1A. <i>Kindly provide the correct certificate duly incorporating the required statement by Statutory Auditor.</i>
