NOTICE INVITING RE-TENDER (NIT)

- Ministry of Road Transport and Highways (MoRTH) through the NHIDCL has been assigned the work of Consultancy Services for preparation of Detailed Project Report (DPR) for stretches Kamenbari to Tenga (Length = 60 Km) in the State of Arunachal Pradesh (as per Annexure-I).**
- Proposals are hereby re-invited from eligible Consultants for the work of Consultancy Services for preparation of Detailed Project Report (DPR) for stretches Kamenbari to Tenga (Length = 60 Km) in the State of Arunachal Pradesh on fixed cost cum quality basis.
The Letter of Invitation (LOI) and Terms of Reference (ToR) including Request for Proposal (RFP) is available online on e-tender portal of <https://eprocure.gov.in>. Cost of the Document of **Rs. 5,900 (Rupees Five Thousand Nine Hundred only) (Including GST)** (Non-refundable) is to be deposited online through online facility provided by the IndusInd Bank to the NHIDCL's Bank account. A copy of payment receipt (RTGS/NEFT/other online mode) must be submitted. For further details and step by step process regarding e-BG and online payment, NHIDCL Office Order dated 22nd March 2023 may be referred, which is attached as Appendix-A. Proof of fee submission shall be submitted along with the online bid.
- The RFP has also been uploaded on "INFRACON" (www.INFRACON.nic.in).** As such before submitting the proposal, the Consultant shall mandatorily register and enlist themselves (the firm and all key personnel), on the MoRTH portal "INFRACON" and furnish registration details along with its RFP. A copy of INFRACON Operation Procedure is also enclosed for bidder's reference.
- All the bidders registered on INFRACON shall form a Team on INFRACON and which would be assigned unique INFRACON Team ID. Bidders while submitting the proposal shall quote the INFRACON Team ID.**
