6. You are requested to submit an undertaking stating that none of your proposed key personnel and sub-professional staff has been blacklisted/debarred by the MoRTH/ its implementing agencies. In case, it is found to be contrary at a later stage, you will have to replace them immediately without claiming any compensation for such staff.
7. You are required to confirm your acceptance of this 'LOA' within 05 days from the date of issue of this letter. As per condition of the contract Clause-13 of Terms of Reference (TOR), you are required to submit the Bank Guarantee (BG) within 15 days of issue of LOA from the bank towards the Performance Security of Rs. 12,74,742.5/- (Twelve Lakh Seventy Four Thousand Seven Hundred Forty Two Only) (2.50% of the Contract Value) valid for a period as specified in the RFP. The Bank Guarantee (BG) shall be in the format in the Appendix-H (Bank Guarantee for Performance security) as given in the RFP.
8. Upon submission of the required Performance Security, you are required to sign the Contract Agreement with NHIDCL. Thereafter, the services shall commence immediately within one month from the date of signing of the Consultancy Agreement and accordingly you are required to mobilize the key personnel including Team Leader and other field staff as per the Contract Provisions, *in Consultation with B.
