NHIDCL has been assigned the work of **Preparation of Detailed Project Report and services for Pre-Construction activities in respect of “Up-gradation & Widening of road to two lane with paved shoulders from Udaipur to Srimantapur (Indo-Bangladesh Border) via Sonamura (approximate length of 35.000 Km) on existing SH-06 in the State of Tripura” for providing better road connectivity to Comilla in Bangladesh.**

Proposals are hereby invited from eligible Consultants for **Consultancy Services for Preparation of Detailed Project Report and providing services for Pre-Construction activities in respect of “Up-gradation & Widening of road to two lane with paved shoulders from Udaipur to Srimantapur (Indo-Bangladesh Border) via Sonamura (approximate length of 35.000 Km) on existing SH-06 in the State of Tripura” for providing better road connectivity to Comilla in Bangladesh.** The Letter of Invitation (LOI) and Terms of Reference (ToR) including Request for Proposal (RFP) is available online on e-tenderportal of <https://eprocure.gov.in>.
