(NHIDCL) under the aegis of Ministry of Road Transport & Highways is engaged in the development of National Highways and Roads under SARDP – NE scheme in the State of Assam. **As part of this endeavor, it has been decided to undertake** “Repair and Maintenance of National Highway (NH 37) between Moran Bypass to Bogibeel (Km. 561.700 to Km. 580.778) (Percentage Rate and Work Order Basis)”

### **The following information is given for consideration by the prospective bidders:**

As per the EPC Contract Agreement, it is the responsibility of the EPC contractors carrying out the 4-Laning work to maintain existing lanes of the project highway in traffic worthy condition. It is however noticed that the EPC contractors at times fail to perform their obligations as per the provisions of the Contract Agreement. Notices have been given/are being given to the EPC contractors to fulfill their obligations as per the Contract Agreement. The bids invited by NHIDCL for Repair and Maintenance works (10 Nos) as per the advertisement published in The Assam Tribune, Purbanchal Prahari and Pratidin on 18.10.2017, and NITs are to carry out the repair and maintenance of the National Highways which are being 4 laned, in case the EPC contractors fail to carry out the repair and maintenance of existing highway and take necessary preventive action to ensure that the existing highway does not get damaged and remains in traffic worthy condition at all times. The repair and maintenance works for which bids have been invited shall accordingly be carried out on as required basis by placing of work order (s) as per site condition.
