Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) for evaluation of Technical Bids for the work "Selection of agency for operation and running of Canteen over the terrace of the Automated Multilevel Car Parking Building, Transport Bhawan, 1-Parliament Street, New Delhi-110001" at NHIDCL HQ, New Delhi on 27.11.2018.

- 1) The Bids for the subject work were invited with Bid Due Date on 19.11.2018.
- 2) In all 03 (Three) Bids were received from the following firms till the scheduled Bid Due Date.
 - a) M/s Prosperity Experts India Pvt. Ltd.
 - b) M/s Hospitalitykart.com
 - c) M/s Cuisines Caterers & Hospitality Services.
- 3) The Empowered Technical Bid Opening Committee (ETBC) opened the bids on 20.11.2018. The technical evaluation of the bids was carried out by the Financial Consultant M/s Amit Ray & Co. to adjudge the technical responsiveness of the bids. The Financial Consultant vide email dated 26.11.2018 submitted the Evaluation Report (*Annexure-I*). The abstract of the Evaluation Report is as under:



4) As regard to **M/s Prosperity Experts India Pvt. Ltd.**, the bidder has clearly mentioned in the bid documents that length of experience of providing services of eating houses/café is 'NIL' and its annual turnover for last three Financial Years is 'NIL'. As regard to **M/s Hospitalitykart.com**, the bidder has not claimed any relevant experience and its average annual turnover is Rs. 10.52 Lakh only which is less than Rs. 50 lakh required as per RFP. Hence, the Committee opined that **M/s Prosperity Experts India Pvt. Ltd. & M/s Cuisines Caterers & Hospitality Services** are technically disqualified due to absence of relevant experience and requisite average turnover as per RFP.

As regards to **M/s Cuisines Caterers & Hospitality Services**, the bidder has Annual Average Turnover of Rs. 5.02 crore and has claimed of having relevant experience of 18 years in providing and running cafe / canteen services in organisations like Maharashtra Sadan, BHEL, TajSATS Air Catering Ltd, however, relevant documentary proof of experience is not submitted with the bid.

5) The Committee opined that since only 02 out of the 03 bidders is already technically disqualified for opening of Financial Bids and only 01 (single) bidder is provisionally qualified, subject to submission of relevant documentary proof of experience, hence, the bidding process may be annulled and the Committee recommends to go for re-bidding for competitive bidding.
