
Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) for evaluation of Technical Bids for the work "Comprehensive Annual Maintenance and Operation of Audio Visual Projection System & Audio Conferencing System installed at Transport Bhawan, Ministry of Road Transport & Highways, New Delhi-110001" at NHIDCL HQ, New Delhi on 12.11.2018.

- 1) The Bids for the subject work were invited on 17.09.2018 with Bid Due Date on 10.10.2018.
- 2) In all 03 (Three) Bids were received from the following firms till the scheduled Bid Due Date.
  - a) M/s Ceeco Technologies Pvt. Ltd.
  - b) M/s Cinesonic Audio Visual Pvt. Ltd.
  - c) M/s M.R.S. Corporation.

3) The Empowered Technical Bid Opening Committee (ETBC) opened the bids on 11.10.2018. The technical evaluation of the bids was carried out by the financial consultant M/s Amit Ray & Co. to adjudge the technical responsiveness of the bids. The Committee deliberated upon the report of the Financial Consultant and opined to seek clarifications from the bidders due to non-submission of certain documents required as per RFP, vide Minutes of Meeting dated 24.10.2018.

4) Accordingly, following clarifications were sought from the 03 (three) bidders. The Financial Consultant deliberated upon the clarifications received from the bidders, and submitted the evaluation report vide letter dated 12.11.2018 (Annexure-I).
