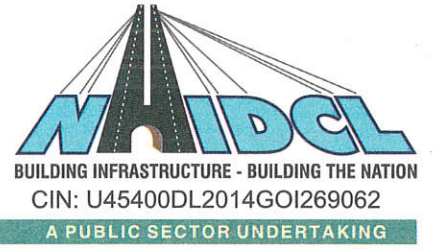

**Subject: Minutes of Meeting of Empowered Technical Evaluation Committee (ETEC) for the “Consultancy Services for Carrying out Feasibility Study, Preparation of Detailed Project Report and providing pre-construction services in respect of 2 laning of (i) Maram-Peren-Dimapur section on NH 129A (Manipur & Nagaland), (ii) Pallel-Chandel Section of NH-102C and (iii) Sangshak-Nampisha on NH 102 A (A Bharatmala Project) on Engineering, Procurement and Construction mode in the state of Manipur” held at NHIDCL on 19.09.2016 - (2<sup>nd</sup> Meeting)**

The RFP for the subject project has been invited with bid due date being 03.08.2016 upto 1600 hrs. The following bidders participated and submitted their bids.

2. In the first meeting of ETEC dated 11.08.2016, the score obtained through infracon were discussed in detail and it was brought to the notice of Committee that the less score reflected through infracon is mainly due to missing details like date of birth, unfilled lane type, unfilled Bridge length, no of bridges, Arbitration cases, inappropriate selection of nature of assignment, alternate selection of mode of project etc. in the CV's of key personnel uploaded on infracon portal. It was also brought to the notice of committee that the due to missing date / unfilled fields of CVs resulted into non-calculation marks by infracon evaluation as software designed to calculate 0 marks in case of any unfilled data which otherwise bonafide for scoring if done manually. The committee therefore for maintaining the transparency and to give equal opportunity to all consultants decided to request all consultants to fill the missing details on the INFRACON Portal. Accordingly, consultant were advised to fill the details initially upto 19.08.2016 vide letter dated 18.08.2016, subsequently reminded vide email dated 30.08.2016.

3. The consultant firm and their key personnel have filled up the missing detail by 15.09.2016. It was also brought to the notice of committee that following discrepancies has been observed in the input sheet of evaluation filled by NHIDCL being first few evaluation through infracon portal have now been rectified and accordingly corrected on INFRACON Portal for the evaluation

The Details of change incorporated either by consultant or in input sheet is attached as Annexure-I. In order to maintain the transparency the complete evaluation process have been prolonged which was also necessitated due to nescient stage of INFRACON evaluation system which need continuous



improvement till robust and error free system / software finalized. The software of INFRACON Portal may be corrected in due course for future evaluation considering above discussed issues. The copy of the final evaluated score through the INFRACON dated 16.09.2016 is also attached as Annexure- II.

4. The M/s S.M. Consultants has failed in the First Stage Technical evaluation i.e. for single project requirement hence not considered for further evaluation. Therefore, M/s S.M. Consultants is **technically disqualified.**

5. Based on the filled up details in CV's by the consultant and modification in input sheet the CV's were evaluated once again through infracon except S.M. Consultants and the marks obtained is as under.

6. All the key personnel's of M/s Eptisa Servicios De Ingenieria, S.L. score more than 75% marks.

7. All the key personnel's of M/s Choice Consultancy Services Private Limited score more than 75% marks.

8. All the key personnel's of M/s Wadia Techno Engineering Services Limited score more than 75% marks.

9. All the key personnel's of M/s Highway Engineering Consultant score more than 75% marks.

10. Committee has also noted that CVs of all key professional have been locked as on 16 Sep 16 and can be updated only for projects after 16 Sep 2016.

11. In view of the above, committee recommends that

(i) Financial bids of the following firms to be opened with the approval of Competent Authority.

(a) M/s Eptisa Servicios De Ingenieria

(b) M/s Choice Consultancy Services Private Limited

(c) M/s Wadia Techno Engineering Services Limited in association with Zoma Consulting Services Pvt. Ltd.

(d) M/s Highway Engineering Consultant in association with Agnitio Infrastructure Projects Pvt. Ltd.

(ii) Following corrections / fields may be added in INFRACON Portal for future projects

(a) All fields should be mandatory and no field shall be kept blank.


(b) For other road / works there should be two more option of single lane and others may be incorporated to accommodate the projects other than NH / SH / Expressway.

(c) Input sheet of Revenue Expert to be filled by profession may be reviewed as brought out above

(d) Stand alone projects issues will be addressed once all input fields are made mandatory.

(e) Input sheet of evaluation shall be made standardized.
