The Bidder, who already possess valid (DSC) “Digital Signature Certificate” need not to procure new Digital Signature Certificate.
9. The bidders have to submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature.
10. Bids will be opened online as per time schedule mentioned at Sr. No. 18.
11. Before submission of online bids, bidder must ensure that scanned copy of all the necessary documents have been attached with bid.

12. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
13. All the required information for bid must be filled and submitted online.
14. Bidders should get ready with the scanned copies of cost of documents & Bid Security as specified in the tender documents. The original instruments in respect of cost of documents, Bid Security and relevant documents etc. may be submitted to the address mentioned in Sl. no. 7 by Registered post/courier/by hand in original on or before i.e., 26.07.2023 till 1500 hours and it should be pledged in the name of Executive Director, Regional Office-Agartala, Tripura.
