Empowered Financial Evaluation Committee (EFEC) assembled on 26.11.2018 for evaluation of financial bid for the Project "Rehabilitation of Km 181.00 to Km 206.00 section in Andaman Trunk Road of NH-4 to Intermediate lane with hard shoulder in the Union Territory of Andaman & Nicobar Islands (Total Length 25.00 km) on EPC Mode (Package-VII)"

2. The committee was apprised that M/s. **Amit Ray & Co**, the Financial Consultant vide their letter dated 26.11.2018 has submitted report on financial bid opening (enclosed at Annexure A) and recommended that bid price quoted by M/s **Garg Sons Estate Promoters Pvt. Ltd** i.e. **Rs. 53.96 Crore** (1.44% below the EPC cost of **Rs. 54.75 Crore**) is the lowest quote among the two technically qualified bidders. Therefore, as per Clause 3.3.1 of RFP, M/s **Garg Sons Estate Promoters Pvt. Ltd.** is recommended to be declared as the "**Selected Bidder**".
3. As per the provision of Article 7.1.1 of DCA, the bidder has to provide Performance Security for an amount equal to 5% (five percent) of the bid price i.e. **Rs. 2.70 Crore**.
4. Accordingly, ETEC recommended to direct the bidder to provide Performance Securities of **Rs. 2.70 Crore** (5% of Quoted Amount i.e. **Rs. 53.96 Crore**) on account of Performance Security.
5. The Committee further recommended to award the work to M/s **Garg Sons Estate Promoters Pvt. Ltd** at their quoted price i.e. **Rs. 53,95,95,101/-** after approval of Competent Authority.
6. Meeting ended with vote of thanks to Chair.
