5. Bid documents can be seen at and downloaded from the website www.nhidcl.com and <https://eprocure.gov.in>. Bid documents contain qualifying criteria for bidder, specification, bill of quantities, conditions and other details.

7. Bidder shall submit the following documents.

 - iii) E-BG/DD/online receipt towards Bid Security.
8. The interested bidder can download the NIT / bidding document from the website <https://eprocure.gov.in> & www.nhidcl.com.
9. The participate in bidding process, bidder have to get (DSC) “Digital Signature Certificate” as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidder can get above mentioned digital certificate from any approved vendors. The Bidder, who already possess valid (DSC) “Digital Signature Certificate” need not to procure new Digital Signature Certificate.
10. The bidders have to submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature.
11. Bids will be opened online as per time schedule mentioned at S. No. 19.
12. Before submission of online bids, bidder must ensure that scanned copy of all the necessary documents have been attached with bid.
13. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
14. All the required information for bid must be filled and submitted online.
15. Bidders should get ready with the scanned copies of cost of documents & EMD as specified in the tender documents. **The original instruments of the technically qualified bidders in respect of EMD and relevant documents will be submitted to the Tenders Inviting Authority by Registered post/courier/by hand on or before the bid due date.**
16. The details of payment towards cost of documents specified in the tender documents should be the same, as submitted online (Scanned copies) otherwise bid will not be accepted.
