- 1) Proposals are hereby invited from eligible Consultants for **Consultancy Services for Authority's Engineer for Supervision of "Rehabilitaion/Maintenance of newly entrusted Churachandpur-Singhat-Sinzawl-Tuivai road section from (i) Km 0.00 to km 34.5 (ii) Km 34.5 to Km 103.1 and (iii) Km 103.1 to Km 161.48 on NH-102B in the state of Manipur on EPC basis.** (hereinafter called as 'Assignment').
