The National Highways and Infrastructure Development Corporation Ltd., (the “Authority”) is engaged in the development of National Highways and as part of this endeavor, “the Authority” has decided to undertake the invites Single Percentage Rate Bids through e-tendering from experienced firms/organizations for maintenance works and activities for the following sections of the National Highway roads:

The Scope of Work includes the routine maintenance of all the assets and facilities existing within Right of Way (ROW) on the above mentioned section including maintenance of carriageway, shoulders, median, bridges, culverts, drains, footpaths, road signage, plantation etc., and carrying out other works as specified in the bid documents.

4. To participate in the in the bidding, it is mandatory for the Bidders to get registered their firm with e-procurement portal <https://eprocure.gov.in/eprocure/app> to have user ID & password which has to be obtained free of cost. Following may kindly be noted:

- (a) Registration with e-procurement portal should be valid at least up to the date of submission of BID.
- (b) BIDs can be submitted only during the validity of registration.

The Bidders shall update their project and other details on the portal on a regular basis and apply to the tenders via the portal.

Bidders are also required to get registered their firm with Bidder Information Management System (BIMS) portal.

The bidder is required to submit, along with its BID, the cost of BID/RFP document, i.e. **Rs.11,800/- in the form of DD in favour of NHIDCL payable at Guwahati (Non-Refundable)**. Failure to submit either of the above will result in rejection of bids.
