2. The National Highways and Infrastructure Development Corporation Limited (NHIDCL) invites bids for the above mentioned Contract Package.

3. **International Competitive bidding** will be conducted in accordance with ADB's [Single- Stage: Two-Envelope](#) bidding procedure and is open to all bidders from eligible source countries as described in the Bidding Document.

IST). Bid must be submitted online only at <https://eprocure.gov.in> on or before 23.03.2020 up to 1100 hours IST.

5. Bid through any other mode shall not be entertained. However, Bid Security, document fee, Power of Attorney and joint bidding agreement shall be submitted physically by the Bidder on or before 24.03.2020 at 1100 hours IST. Bids received shall be opened on 24.03.2020 at 1500 hours IST.

6. To participate in the e-tendering process, a Bidder should be in possession of Class III Digital Signature Certificate (DSC) in the name of the person duly authorized to sign on behalf of the Bidder from any of the licensed Certifying Agency (CA) (The shortlisted bidders can see the list of licensed CA's from the link <https://www.cca.gov.in>).

7. To participate in the E-Bid submission, it is mandatory for the bidder to register their firm/Joint Venture with e-procurement portal of NIC <https://eprocure.gov.in> to have a user ID and password.
