National Highways & Infrastructure Development Corporation Limited (NHIDCL), a fully owned PSU of the Ministry of Road Transport & Highways (MoRT&H), is engaged in the development of National Highways & Infrastructure works and as part of this endeavour, it has been decided to undertake “Design, Construction, Supply, Transportation, Installation, Testing and Commissioning of Steel Pontoons and Gangways using suitable Steel Enveloped HDPE / FRP floating material for providing floating Terminal facilities at various locations on NW – 2 (Brahmaputra)” through an Engineering, Procurement and Construction (EPC) Contract.
