3. **International Competitive bidding** will be conducted in accordance with ADB's [Single- Stage: Two-Envelope](#) bidding procedure and is open to all bidders from eligible

source countries as described in the Bidding Document.

5. Bid through any other mode shall not be entertained. However, Bidder is required to submit along with its Bid, a Bid Securing Declaration (as per the given format), document fee, power of Attorney and joint bidding agreement shall be submitted physically by the Bidder on or before **13.01.2020** at **1500 hours IST**. Bids received shall be opened on **13.01.2020** at **1530 hours IST**.

6. To participate in the e-tendering process, a Bidder should be in possession of Class III Digital Signature Certificate (DSC) in the name of the person duly authorized to sign on behalf of the Bidder from any of the licensed Certifying Agency (CA) (The shortlisted bidders can see the list of licensed CA's from the link <http://www.cca.gov.in>).

7. To participate in the E-Bid submission, it is mandatory for the bidder to register their firm/Joint Venture with e-procurement portal of NIC <https://eprocure.gov.in> to have a user ID and password.
