Section-2 Instruction to Bidders, Clause 2.1.15 of RFP	The bidder including individual or any of its JV members, who are having 2 (two) on-going EPC projects in NHIDCL or on-going projects worth Rs.500 cr. (awarded cost) or more in NHIDCL, as on the date of financial bid opening, shall not be eligible to bid for this project.(Issuance of LOA will be considered as On-going project)	The bidder including individual or any of its JV members or its related parties, who are already having two on-going EPC projects in NHIDCL or on-going projects worth Rs.500 cr. (awarded cost) or more in NHIDCL, as on the date of financial bid opening, shall not be eligible to bid for this project. <i>Explanation :</i> (i) An LOA issued for any project shall be counted as an on-going project. (ii) Projects having EPC cost of Rs. 25 Crores or less shall not be counted for this purpose. (iii) In case of a company, the Related Parties means Related Parties as defined in the Companies Act, 2013, and in case of a bidder other than a company, the Related Parties means bodies in which the bidder or its partners are partner, trustee or directors in other bodies whether incorporated or not.
