9. The bidders have to submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature. No proposal will be accepted in physical form.

11. Before submission of online bids, bidder must ensure that scanned copy of all the necessary documents have been attached with bid.
12. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
13. All the required information for bid must be filled and submitted online.
14. Bidders should get ready with the scanned copies of cost of documents & EMD as specified in the tender documents. The original instruments in respect of EMD and relevant documents will be submitted to the Tenders Inviting Authority by Registered post/courier/by hand before the issuance of LOA.
