

TERMS AND CONDITIONS

1. The vehicles should be in good condition and not older than (01) one year. The self-attested copy of the registration certificate as well as insurance certificate and copy of purchase document should be submitted along with the bids.
2. The vehicle must have commercial registration number.
3. The Agency shall also provide a driver, having valid driving license from RTO, at all times. The validity of registration, insurance, fitness certificate etc to be ensured by the agency. All necessary taxes for operating the vehicles shall be fully paid by the agency as per the prevailing Motor Vehicles Act with Insurance cover. The agency has to provide well behaved/uniformed driver with mobile phone.
4. The deployment of the vehicle shall be normally 12 hrs per day but this office reserves the right to use the vehicle round the clock without paying anything extra. Vehicle shall primarily run in the jurisdiction of RO-Itanagar.
5. All cases related to accident/damage/compensation shall be responsibility of the Agency.
6. The Agency shall bear all expenses required for keeping the vehicles in smooth running condition such as fuel, lubrications oil & other consumables, necessary service & maintenance, repairs & replacement etc. are to be borne by the agency.
7. In the event of any vehicle being off the road for maintenance or on any account of breakdown/accident or for any other reason, the Agency shall provide a substitute vehicle immediately. If the Agency at any time fails to provide substitute vehicle as specified above, an amount of **Rs.2500/-** per day or part thereof for each day that the Agency fails to provide shall be deducted from the Agency's account.
8. The monthly hiring charges quoted shall include maintenance charges, driver's salary and inclusive of all taxes etc except Fuel charges for upto 3000 Km.
9. Fuel charges shall be paid extra as per actual running kilometer run during the month based on Fuel consumption norm taken as **8 Km per Litre (For Innova Crysta)** and **12 Km per litre (for Bolero/Brezza/equivalent)**.
10. Beyond 3000 Km, the rate per Km should be quoted towards Fuel and all charges.
11. For Innova. double compressor Air condition shall be available in the vehicle.
12. Parking Fee and Toll Fee for the official use of the vehicle will be reimbursed on actual basis after authentication by concerned officer.
13. The meter of the vehicle must always be kept in proper running condition to record the actual running of the vehicle in Km. A log book will be maintained by the Regional Office, Itanagar to record the movement of the vehicle.
14. The Agency should quote their bill on monthly basis i.e. per vehicle per month.
15. The Agency should ensure that sufficient fuel is always available for travel.
16. The quoted rates for hire charges should be valid for two years from the date of acceptance. Variation/Revision in quoted rates on account of any increase in spares/maintenance/insurance/driver salary will not be entertained during the contract period.
17. Vehicle can be withdrawn from usage after 7(Seven) days of advance written notice to the Agency.
18. Quantity indicated may be increased if requirement arise at later stage.
19. The Agency should submit their bills in original along with fuel filling receipts and copy of logbook within 1<sup>st</sup> week of every month for payment.
20. The jurisdiction of vehicle moving in Arunachal Pradesh and other North Eastern States.
