Responsiveness	Annex I	In Annex I submitted by the Bidder, after point 7, in the table, first point is not fully mentioned i.e. ‘Fails to complete or has missed more than two milestones in already awarded two or more projects, even after lapse of 6 months from the scheduled completion date, unless Extension of Time has been allowed on the recommendations of the Independent Engineer due to Authority's default;’ Please Clarify.
3.	Responsiveness	Annex VIII	Annexure VIII i.e. Details of ongoing works (Ref Clause 10.3 (iv) of Draft EPC Agreement) is not found in the submitted Bid. Please Clarify.
4.	Responsiveness	Undertaking	In the undertaking submitted by the Bidder ‘to abide by the Bid documents’ Authority name is mentioned as MORTH instead of NHIDCL. Please Clarify.
5.	Responsiveness	Appendix II	In Bank Guarantee submitted by the Bidder, In first para, first line, name of the Authority is mentioned as Ganpati Builders instead of NHIDCL. In point 3, in last sentence, words ‘ Any such Bank under this Guarantee. However, our liability under this Guarantee shall be restricted to an amount not exceeding Rs 22.63 Lakh (Rupees Twenty Two Lakh and Sixty Three Thousand Only)’ is mentioned instead of ‘Any such demand made on the Bank shall be conclusive as regards amount due and payable by the Bank under this Guarantee. However, our liability under this Guarantee shall be restricted to an amount not exceeding Rs 22.63 Lakh (Rupees Twenty Two Lakh and Sixty Three Thousand Only)’.
