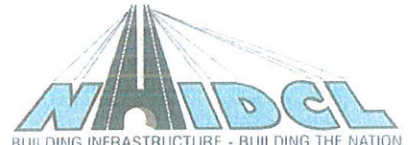

The Bank Guarantee (BG) shall be in the format in the Appendix-H (Form of Performance Security) as given in the RFP.

4. Upon submission of the required Performance Security, you are required to sign the Contract Agreement with NHIDCL. Thereafter, the services shall commence immediately after signing of the Consultancy Agreement and accordingly you are required to mobilize the key personnel including Team Leader and other field staff as per the Contract Provisions.

5. Kindly note that your firm will fully engage itself with work and articulate the role of Associates partner and itself.

6. You are requested to sign and return the duplicate copy of the LOA (copy enclosed) in acknowledgement thereof, at the earliest.
