QUALIFICATION CRITERIA:

ESSENTIAL QUALIFICATION FOR THE BIDDER:

1. Should have minimum five years experience and private establishments' expertise in undertaking similar works with the Government Department. Proof to this effect may be submitted along with the bids.
2. Should have completed at least three works **Providing, Supply & Fixing of 2 Hours fire rated door** during the last (3) three years.
3. Should have registered for GST, please enclose proof thereof.
4. Should have PAN No and copy of the same shall be submitted along with the bid.
5. Affidavit to the effect that firm has not been blacklisted by any of the Govt. Agency on a non judicial stamp paper worth Rs.100/- duly notarized from the public notary.
6. Have the Test Certificate from CBRI, Roorkee in their own name for similar door assemblies. The certificate should not be more than three years old.
7. In the absence of any of the above documents, the bids shall be summarily rejected and no correspondence in this regard will be entertained.
8. Tender Fee of Rs.1,000/- shall be deposited along with the tender in the form of DD/Pay order in favour of "Managing Director, National Highways & Infrastructural Development Corporation Ltd", payable at New Delhi.
9. Earnest Money of the work is Rs.10,000/- shall be deposited along with the tender in the form of DD/Pay order in favour of "Managing Director, National Highways & Infrastructural Development Corporation Ltd", payable at New Delhi.
10. Financial bids of only technically qualified bidder shall be opened.
11. 10% of the quoted price shall be withheld as Security Deposit during the DLP of one year from the day of completion of work.
12. **Technical Bid must contain one photo copy of unfilled bid document duly signed & stamped by an authorized person on each page as a token of acceptance of all Terms & Conditions of NIT.**

The pre-qualification/ post-qualification of the bidders would be based purely upon their capability, competence, capacity, resources, experience and expertise. The bidders would be required to submit documentary evidence(s) in support of the above criteria along with their proposals.

GENERAL TERMS & CONDITIONS

Name of Work:- Providing, Supply and Fixing of 2 Hours fire rated door at NHIDCL, 3rd Floor, PTI Building, 4-Parliament Street, New Delhi-110001.

The Terms & Condition for the above cited work shall be as under:-

1. The time allowed for the completion of work is 30 days from the day of award of work (including fabrication of the door) after issue of award letter and has to start the work immediately on award of the work.
2. Extension of time shall normally be not permitted, however, in case necessary the permission of the same may be obtained from NHIDCL in writing giving reasons thereof.
3. The rates quoted shall be for complete work, inclusive of applicable taxes. The bidder must quote the rates all inclusive. The work will be awarded to the technically qualified bidder who is L-1 in overall bidding on turnkey basis.
4. The work involves removing of existing door installed at NHIDCL and fixing the fire door of the approved specifications. Interested bidder may inspect the establishment (NHIDCL) at 3rd Floor, PTI Building, 4, Parliament Street, New Delhi-110001 during office hours on all working days, in order to assess and understand the scope of work, failing which the bidder will be responsible for consequences there from.
5. The bids shall remain open for acceptance for a period of 60 days from the date of opening of tender.
6. NHIDCL reserves the right to accept/ reject any of the tender without assigning any reason whatsoever.
7. The bids shall be submitted in dual bid system in separate sealed envelopes clearly mentioned on the top of envelopes as "Technical Bid" and/or "Price/ Financial Bid".
8. Bad workmanship is liable to be rejected and no payment on that account will be made.
9. No Advance payment/Mobilizing advance will be made to the contractor/ bidder. The payment shall be released after completion of the work. The contractor shall submit the final bill with detail of measurement, which will be checked and verified by the Engineer in-charge of NHIDCL.
10. 90% of the total payment shall be released to the contractor after statutory deductions of TDS etc., on satisfactory completion of the work, remaining 10% will be kept as Security Deposit till the defect liability period i.e. one year from the date of completion of the work.

11. In case any defect is notice during the DLP, the contractor would be liable to rectify the same within 7 days, failing which; NHIDCL will get the same rectified at the risk & costs of the contractor.
12. In case any extra work is required to be executed for installed Fire Doors at NHIDCL, the same shall be executed with the prior approval of the competent authority, in writing.
13. The rate of extra item shall be based on DSR-2016 (plus applicable enhancements). However, the materials which are not covered in DSR shall be as per current market rate, which is also subject to prior approval of the competent authority in NHIDCL.
14. The contractor shall clean the waste material, which is used during progress of work from the floors and doors, immediately after the work and no extra payment, will be made on this account.
15. The contractor shall be fully responsible for the safety precautions, Labour Laws and payment of Labour cess, GST or any other Taxes directly to the concerned department. NHIDCL shall not entertain any claim whatsoever in this respect.
16. The contractor shall comply with minimum wages act and no minor labour should be engaged at the work site.
17. The contractor shall be responsible for any damage to the equipment, furniture, structure or injuries to the personnel during the progress of the work and he shall be liable to pay such compensation as may be decided by the competent authority of NHIDCL in respect of such damage/ injuries.
18. Contractor or his qualified authorized representative should always be available at the site of work to take the instructions from the Engineer in-charge, NHIDCL and ensure proper execution of work.
19. The work shall be carried out in the required manner to causing minimum disturbance to the working of NHIDCL.
