RFP for “Construction of Automated Multilevel Tower car parking facility at Ernakulam South Metro station, Kochi, Kerala.”

National Highways& Infrastructure Development Corporation Ltd. (hereinafter called “the Employer”) on behalf of KMRL hereby invites item rate bids on two bid systems through e-tendering for the following work from experienced firms/organizations excluding those firms who have been declared as non- performing by MoRTH/NHAI/MoSHIPPING/NHIDCL or the firms those are blacklisted/ debarred for specified period by MoRTH/NHAI/MoSHIPPING/NHIDCL and against whom such action is under process by MoRTH/ NHAI/MoSHIPPING/NHIDCL

The NHIDCL represented by Managing Director,invites bids from eligible contractors for the following project:

Note:

- i. For the minimum eligibility criteria in clause referred above, successfully completed portion of any ongoing work will also be considered.
 - ii. In case of Joint Venture, the work done either by the same joint venture or by any member of the joint Venture shall be considered for minimum eligibility criteria. The work, if done in Joint Venture will be taken as per the percentage participation.
 - iii. The documentary proof such as Completion Certificates from Clients and concerned Consultant/Architect for such work should be submitted clearly indicating the technology, ECS and Final completion cost and overall completion period of the work. The offers submitted without these documentary proof shall not be evaluated and shall be treated non-responsive
 - iv. A bidder must have experience of similar works as Original Equipment Manufacturer (OEM). In case, a bidder does not have experience as OEM, he may participate by having MoU with an OEM.
 - v. Joint Venture is allowed of maximum 2 partners/members, out of which one should be Original Equipment Manufacturer (OEM) and JV or any member has executed Automatic car parking with Tower/Robo-shuttle technology including Building/Structure work either Overground or Underground in India in the last 7 years ending on the date of publication of tender.
 - vi. Original Equipment Manufacturer (OEM): provision of technology, installation, testing and commissioning of automated car parking system with tower/robo-shuttle technology as shown in the tender drawings of minimum 03 (three) system in India / 10 (ten) system world over and must have an experience of operation and maintenance of the system of comparable technology for minimum 2 years totalling 75 ECS.
 - vii. The Bidder, including individual or any of its JV member, who are either having 2 (two) on-going EPC Project(s) in NHIDCL or on-going Project(s) worth of Rs. 500 Cr. (Awarded Cost) or more in NHIDCL, as on date of bid submission, shall not be eligible to bid for this Project (Issuance of LOA will be considered as on-going project).
 - viii. The firms or personnel from neighbouring countries sharing common land border with India are not eligible to bid for the subject project. Such firms will be treated as 'Non responsive'.
 - ix. The technology and material from the neighboring countries sharing common land border with India is not permitted.
 - x. Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc. or debaring from MoRTH/NHIDCL/NHAI/MoSHIPING work etc. During last 5 years.
 - xi. MSME having valid NSIC registration certificates issued for providing similar services will be allowed exemption from EMD etc, subject to submission of valid registration certificate with the bid as per the Govt. policy.
3. The scope of work:
The Scope of Work is as per Bill of Quantities for the subject work.

4. The authorized signatory holding Power of Attorney shall only be the Digital Signatory. In case, authorized signatory holding Power of Attorney and Digital Signature are not the same, the bid shall be considered non-responsive.
5. To participate for the bidding, bidders have to pay non-refundable document fee of Rs. 5,900/- (inclusive of GST @18%) which shall be deposited online (RTGS/NEFT/Other online mode) only, to the NHIDCL's Bank account (Account details as tabulated below) and the bidder must furnish a copy of the online transaction receipt while submitting the proposal:
