MSME registered /NSIC registered agencies for doing similar work are exempted from payment of EMD, as per Govt policy.
2.	Page 36, clause 30, section-IV	The rate quoted by the contractor shall be considered inclusive of all taxes including GST.	It is mentioned in the tender clauses that GST is inclusive, but in BoQ, it is mentioned that GST to be mentioned separately. Hence, need clarity.	The basic rate to be quoted, shall be excluding GST. Please refer to Addendum dated 13.11.2020 issued in this regard.
3.	Item No270 of BoQ	-	Drawing or specifications of Art work need to be provided to quote properly	The item has been deleted from the BoQ.
4.	Item No122 of BoQ	-	The specifications mentioned are not clear. Due to a specific brand, vendors/suppliers are not giving rate to other parties. Equivalent brands should be permitted.	BoQ has been amended, equivalent brands are permitted.
