- (a) Registration with e-procurement portal should be valid at least up to the date of submission of BID.
- (b) BIDs can be submitted only during the Validity of registration.

The Bidders shall update their project and other details on the portal on a regular basis and apply to the tenders via the portal.

Bidders are also required to get registered their firm with Bidder information Management System (BIMS) Portal

6. The authorized signatory holding Power of Attorney shall only be the Digital Signatory. In case authorized signatory holding Power of Attorney and Digital Signatory are not the same, the bid

shall be considered non-responsive.

7. The last date for online submission of the Bid is **29.01.2024 17:00 hrs** (“**Bid Due Date**”). The bids would be opened on **30.01.2024. (17:30 hrs)**. Bidder must submit its Financial Bid & Technical Bid on CPPP e-Procurement portal within the above deadline. The Bids would be opened on **30.01.2024 at 17:30 Hrs.**, representative of the bidders (Maximum of Two) who chose to attend, may attend the online opening of the bids at **Regional Office-Aizawl, on the date and time as mentioned above**. However, such representatives shall be allowed to attend the opening of the bids only if they produce letter of authority on the letterhead of the bidder, at the time of opening of bids as mentioned above.

8. The amount of Bid Security is **Rs 1,39,781.00 (One Lakh Thirty-Nine Thousand Seven Hundred Eighty-One rupees only)**

9. The period of validity of bid is 120 days from the deadline of submission of bid.
