1	General	<p>i) It has been observed that Power of Attorney is in favour of Mr. Manu Thomas and Bid is digitally signed by Mr. Sanjeev Trehan. Hence the person authorized in POA and person who digitally signed the Bid is Different. Bidder to clarify.</p> <p>ii) Integrity Pact and Undertaking is not submitted by Bidder Bidder is requested to submit Integrity pact and Undertaking as it is mentioned in Clause 2.11.1 to submit the same.</p>
2	Annex II (Technical Capacity of Bidder) and Annex IV (Details of Eligible Projects)	<p>iii) The Bidder is claiming one project of Rs. 4.52 Crore in Annex II and Annex IV. However the minimum technical threshold required is Rs. 6.31 Crore. Hence the Bidder is not meeting the minimum technical threshold in terms of Clause 2.2.2.2 (i) Bidder to clarify.</p> <p>iv) Category of road cannot be identified. Further Completion date is not there in Statutory Auditor Certificate. Bidder to clarify.</p>

3	Undertaking regarding non- audit of Financials of 2018-19	v) The Undertaking regarding non- audit of Financials of Financial Year 2018-19 is not given as required under Clause 2.2.2.8(ii). Accordingly figures of Four FY i.e. from FY 2014-15 to FY 2017-18 have been considered for evaluation.  Bidder to clarify why such undertaking has not been provided.
4	Annex V (Statement of Legal Capacity)	vi) Annex V submitted by Bidder is not in proper Format as given in RFP. The bidder is requested to resubmit Annex V in proper Format.
