2 Based upon the Technical evaluation of bids, out of four bidders M/s S.P. Singla Constructions Pvt. Ltd., M/s RDS-VNCPL (JV), M/s Dineshchandra R. Agrawal Infracon Pvt. Ltd. were declared qualified for next stage of evaluation i.e. Financial Bid Opening and one Bidder M/s Supreme-Agrawal (JV) was declared disqualified due to **“Not fulfill the criteria of the RFP as per Section no. 3 (EQC) of Clause 2.4.1”**

3. The Financial Bids of the three technically qualified bidders were opened on 14.11.2017. The price quoted by each of the three technically responsive bidders are as follows:

(i) M/s Dineshchandra R. Agrawal Infracon Pvt. Ltd.	- Rs. 103,78,00,000.00
(ii) M/s S.P. Singla Constructions Pvt. Ltd.	- Rs. 105,57,00,000.00
(iii) M/s RDS-VNCPL (JV)	- Rs. 159,49,00,000.00

4. Based on the evaluation of Financial bids, the work has been awarded to L-1 Bidder M/s Dineshchandra R. Agrawal Infracon Pvt. Ltd. at contract price of Rs. 1,03,78,00,000/- (Rupees One Hundred Three Crore Seventy Eight Lakh Only).
