
Refer the subject cited above, financial bids of following technically responsive bidders were opened on 19.03.2018 at 1100 Hrs. The financial evaluation result is as under:

2. It has been decided to award the work to lowest evaluated bid as per Clause 39 of Section 1 of RFP, M/s G.R Infra projects Limited at the price of Rs 457,77,00,000/- . The period of contract includes construction period of 3 years and Defect Liability Period including the maintenance of the project of 5 years with effective from Appointed Date.

3. The selected Bidder (the "Contractor") shall be responsible for designing, engineering, procurement and construction of the Project under and in accordance with the provisions of an engineering, procurement and construction contract (the "EPC Contract") to be entered into between the Contractor and the Authority in the form provided by the Authority as part of the Bidding Documents.
4. The scope of work will broadly include rehabilitation and capacity augmentation of the existing two lane carriageway to two lane carriageway standards with construction of new pavement, rehabilitation of existing pavement, construction and/or rehabilitation of major and minor bridges, culverts, road intersections, interchanges, drains, etc. Defects Liability Period shall be 5 years including maintenance of the Project for a period of 5 (Five) years.
