Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) for evaluation of Technical Bids for “Supplying, Installation & Commissioning of Fire Fighting System from Automated Car Parking Building in Transport Bhawan to Pump Room of Shram Shakti Bhawan, New Delhi-110001” at NHIDCL HQ, New Delhi on 13.07.2018.

- 1) The Bids for the subject work were invited on 18.05.2018 with Bid Due Date on 25.06.2018.
- 2) In all 03 (Three) Bids were received from the following firms in physical form as well as online till the scheduled Bid Due Date.
 - a) M/s Such Raj Safety Systems Pvt Ltd.
 - b) M/s San Infotech Services.
 - c) M/s MGK Hydraulics Engineers Pvt Ltd.
- 3) The Bids were opened by Empowered Technical Bid Opening Committee (ETBC) on 26.06.2018. Further, the technical evaluation of the bids were carried out by Empowered Technical Bid Evaluation Committee (ETEC) on 02.07.2018.
- 4) ETEC vide its Minutes of Meeting dated 02.07.2018 (Annex-I) observed that some documents submitted by the aforesaid firms were inadequate to adjudge the responsiveness of the bids and therefore, the Committee decided to seek clarifications from the aforesaid bidders. Accordingly, the bidders were asked to submit the clarifications as tabulated in the succeeding para.
- 5) Clarifications were received from the aforementioned 03 (three) bidders and the Committee perused the clarification received and the comments are as under:

(A) M/s Such Raj Safety Systems Pvt Ltd.

We may consider the Average Annual Turnover for the years 2016-17, 2015-16 & 2014-15. By considering the annual turnover for the aforesaid years, the Avearge Annual Turnover sum up to Rs. 39.39 lakh, which is more than Rs. 14.91 lakhs required as per the provision of RFP. <i>Hence Eligible.</i>

- 6) Keeping in view para 5 above, the Committee found that all the 03 (Three) bidders i.e. a) M/s Such Raj Safety Systems Pvt Ltd. b) M/s MGK Hydraulics Engineers Pvt Ltd & c) M/s San Infotech Services are technically responsive for opening of financial bids.
- 7) The ETEC recommends the opening of financial proposals of the aforesaid bidders after the approval of the Competent Authority.
