It has been resolved to modify this para as under:- "The Advocate/Law Firm shall submit its bill preferably within one (1) month from the date on which the fee has accrued".
7.	6.15- The concern was raised towards increasing the number of working days for the advocates/law firm to render his opinion.	It has been resolved to modify this point as under:- "when any case is attended by the Advocate/law firm and if the same is decided against the NHIDCL, then Advocate/Law Firm shall render his/her opinion, without any cost, regarding filing of an appeal arising out of such decision not later than seven (7) working days from the date of receipt of copy of the judgment/order".

3. It is also notified for information of all concerned that the last date for submission of applications has been extended upto 11.07.2019 (upto 1600 hrs) instead of 04.07.2019 notified earlier. Rest of the contents of EOI remain the same.
