**Minutes of the meeting of Empowered Technical Evaluation Committee (ETEC) held on 08.02.2018** for Consultancy Services for Authority's Engineer for supervision of "Four laning of Balachera to Harangajao section of NH-54(Ext) from km 275.000 to km 244.000 in the State of Assam on EPC mode".

1. Having carried out technical evaluation, ETEC in its meeting dated 22.01.2018 recommended for seeking comments from both the bidders on the carried out technical evaluation within 7 days. Out of the two responsive bidders, one bidder viz. M/s Technocrats Advisory Services Pvt. Ltd. in association with Agnitio Infrastructure Projects Pvt Ltd has submitted its comments on the revised evaluation results.


2. While examining the comments received from the bidders, ETEC in this meeting observed that M/s Technocrats Advisory Services Pvt. Ltd. in association with Agnitio Infrastructure Projects Pvt Ltd has claimed 1.75 marks for "Average Annual Turnover from consultancy business" whereas INFRACON has allotted 1.5 marks for this evaluation criterion. The ETEC observed that the bidder has not uploaded data on INFRACON for turnover for the year 2016-17; neither the CA certification for Annual turnover submitted by the bidder for supporting its claim indicates turnover for the financial year 2016-17. As such, the claim of the bidder was not found tenable and thus, rejected by the ETEC. ETEC further observed that all the other claims of M/s Technocrats Advisory Services Pvt. Ltd. in association with Agnitio Infrastructure Projects Pvt Ltd have already been addressed to in the earlier evaluation dated 22.01.2018.


3. The score/ status of the firms remain unchanged as mentioned below:
