1. The bids for subject work were invited on 14.11.2017 and physically received on/before scheduled bid due date (online & physical submission) 09.03.2018 upto 1100 hrs.
2. ETBC met to open the Technical bid on 12.03.2018 at 1100 Hrs. The following bidders have submitted their bids physically as well as online –

3. The hard copies of the bids were opened and after verification of PoA and DSC details the online bids were also opened and verified. The hard copy of the original documents along with the soft copy (as received from E-bidding service viz. <https://eprocure.gov.in/cppp/>) were handed over to the concerned Financial Consultant M/s MKPS & Associates for carrying out the evaluation of the Technical Bids.

The Financial Consultant M/s MKPS & Associates during preliminary RFP evaluation found that some of the data/information provided by 2 (two) Bidders namely M/s Bharat Vanijya Eastern Private Ltd. and M/s Shivalaya Construction Co. Pvt. Ltd. are inadequate or requires clarification for further evaluation. It is proposed by the Financial Consultant to seek clarification from the Bidders before further evaluation. 
