The Executive Committee discussed the Agenda items and the recommendations/ decisions are indicated below:

Item No.1. Four laning of Dolabari to Jamuguri section from Km 17.300 of NH - 37A to Km 182.00 of NH-52 in Assam under SARDP-NE, Phase A on EPC mode -Recommendation of Change of Specification proposal for River Training Works by Tech Revetment Technology -Issue of COS Notice reg.

Decision:

The Executive Committee deliberated the Agenda and after detailed discussions, approved the proposal subject to the condition:

- (i) Additional Defect liability period (DLP) of 5 years for Tech Revetment Technology.
- (ii) Signing of Supplementary Agreement for additional DLP and no claim whatsoever with regard to COS proposed by the Contractor.
- (iii) ED (P) to work out the rebate amount proposed by the Contractor and seek approval from HQ.

Item No. 2. Consultancy Services for Authority's Engineer for four laning of Dolabari to Jamuguri section from Km 17.300 of NH-37A to Km 182.000 of NH-52 in Assam under SARDP-NE, Phase A-Request for Providing additional sub-professional for effective work monitoring -reg.

Decision: The Executive Committee deliberated the Agenda and after detailed discussions, approved the deployment of following additional manpower as proposed by the AE for effective monitoring and supervision of work:

- 1. 1 No. Lab Technician @ Rs. 92000/- per month for 14.45 months
- 2. 1 No. Assistant Bridge Engineer @ Rs.92000/- per month for 14.45 months
- 3. 1 No. Assistant Highway Engineer @ Rs.92000/- per month for 14.45 months
- 4. 1 Vehicle Mahindra Bolero @ Rs. 25000/- per month for 14.45 months

The AE to set up separate office at his own cost for above additional staff on the site for effective monitoring as proposed by the AE. GM(P) to ensure compliance.

Item No. 3. Construction of Extra-dosed RCC Bridge including viaduct and approaches over river Feni at Sabroom on Indo-Bangladesh Border on NH-8 in the state of Tripura on EPC mode - Shifting of Milestone- reg.

Decision: The Executive Committee deliberated the Agenda and after detailed discussions, approved the proposal for shifting of Milestone I (173 days), II (173 days) and III (160 days) subject to the condition that overall project completion would be as per the scheduled time i.e. 26.04.2020.

Project Report for Improvement and widening to two lane with paved shoulder of newly declared NH-208 (Kailasahar - Teliamura) in the state of Tripura- Additional work (Redesign, Site Visit, Meeting & Non-Title Holder data collection)-reg.

Decision: The Executive Committee deliberated the Agenda and after detailed discussions, approved additional cost to the tune of Rs. 29.30 lacs for Additional work as per requirements of JICA and collection of additional data of Non Title holders excluding taxes to the DPR Consultants.

- Item No. 5. Construction of two-Lane with hard shoulders of Merangkong-Tamlu-Mon Road from existing Km 60.345 to 98.065 [Design Km. 59.000 to Km. 86.835] (Design Length 27.835) in Nagaland under SARDP-NE-Descoping of work reg.
- Decision: The Executive Committee deliberated the Agenda and after detailed discussions, approved the withdrawal of works under Cl. 8.3.3 to the tune of Rs. 48.76 Cr resulting in a payment of Rs. 4.876 Cr to the Contractor as per the Contract Agreement.
