**Item No.1.** Approval for Sub-Contracting the works up to 49% in EPC Projects.

**Decision:** The Executive Committee deliberated the Agenda and after detailed discussions, decided to defer it to the next meeting.

Item No. 2. Establishment of a Conciliation & Settlement Mechanism for Contractual Disputes arising under the contract agreements with the Contractors/ Consultants/ Concessionaires in NHIDCL.

**Decision:** The Executive Committee deliberated the Agenda and after detailed discussions, decided to adopt a policy of Conciliation with regard to ongoing disputes for which a procedure shall be drafted by HR division and submitted before the next EC.

Item No. 3. Consultancy Services for Topographical, Traffic, Geological/Geotechnical Survey and Data collection for widening and up gradation of National Highways in the NER-Final Bill against submission of Traffic Survey Report and Topographical Survey Report.

Item No. 4. Special arrangement for delayed EPC Contracts.

Decision:

The Executive Committee deliberated the Agenda and after detailed discussions, decided to replace para 4(v) of the Circular dated 17.01.2020 with the following:

4(v) 'Considering the functional requirement of speedy execution of projects without loss of the working season, availability of Bank Guarantees and legal restrictions on furnishing the personal guarantee by the Promoters and whole time Directors, the condition of the personal guarantee is relaxed subject to the condition that Bank Guarantees of these projects shall remain available till the completion of the delayed projects and that the contractor shall not be allowed to bid for future projects of NHIDCL, till the completion of the existing delayed projects'.

The Supplementary Agreement should also provide for this.

Item No. 5. Four laning of NH-37 for Rangagara to Kaliabor Tiniali (Ch 297.000 to Ch 315.315) in Nagaon District in Assam under SARDP-NE, Phase A, on EPC basis - Special arrangements for delayed EPC contract- reg.

Decision:

The Executive Committee deliberated the Agenda and after detailed discussions, decided to allow the ED(P), Guwahati to proceed ahead as per the amended Circular. Sh. Tirtha Roy, GM(P), Namsai shall be the nominee from the HQ in terms of the requirement of para 3(c) of the Circular dated 17.01.2020.
