Members of the Executive Committee discussed the Agenda items under the Chairmanship of MD, NHIDCL through **Circulation Method** and the recommendations/ decisions are indicated below:

Item No.1. Construction and upgradation of existing road to 2 lane with paved shoulder including geometric improvement from Ranipool- Pakyong from Km 0.00 to Km 16.167 of NH-717-A on EPC base under SARDP-NE Phase-A in the State of Sikkim- Extension of time-reg.

Decision: The Executive Committee deliberated the Agenda and after detailed discussion approved the Extension of Time.

Item No. 2. Two laning of Existing Hunli-Anini Road on EPC Basis from Design Km. 21.500 to Km. 37.500 (Existing Km 21.450 to Km 40.160) in the State of Arunachal Pradesh Under SARDP-NE-Extension of Timereg.

Decision: The Executive Committee deliberated the Agenda and approved Extension of Time - 03 of Milestone III from 20.02.2020 to 31.07.2020 and Scheduled Completion date from 15.08.2020 to 24.01.2021 without any financial implication.

Item No. 3. Construction of Two laning of Existing Hunli-Anini Road on EPC Basis from Design Km. 106.200 to Km. 120.000 (Existing Km

111.600 to Km 126.875) in the State of Arunachal Pradesh Under SARDP-NE-Extension of Time (EOT)-2 reg.

Decision:

The Executive Committee deliberated the Agenda and approved the Extension of Time-02 of Milestone III from 31.12.2019 to 08.07.2020 and Scheduled Completion date from 31.03.2020 to 03.01.2021 without any financial implication.

Item No. 4. 2 laning with paved shoulders from km 6.25 to km 10.400 of Silchar-Badarpur section of NH-53 (Length = 4.77 km) in the state of Assam on EPC mode- Change of Scope Order reg.

Decision:

The Executive Committee, after detailed deliberations, recommended to issue Change of Scope Order amounting to Rs. 2,85,69,547/- (Two crore Eighty Five Lakh Sixty Nine Thousand Five Hundred Forty Seven only) excluding GST as Cl. 13.2.4 of Contract Agreement to EPC Contractor M/s Shree Gautam Construction co. ltd. for the subject project for items already approved and conveyed vide COS notice letter no. 3041 dated 14.11.2019 which was approved in 75th meeting of Executive Committee.

Item No. 5. Construction of (i) 14.150 km long bi-directional tunnel across Zojila Pass on Sonamarg-Kargil section of NH-01 and (ii) Connecting road from Z-Morh Tunnel to Zojila Tunnel on EPC mode in the Union Territories of J&K and Ladakh- Draft minutes for Executive Committee -reg.

Decision:

The Executive Committee deliberated the agenda and after detailed discussion, the Committee accorded its approval for invitation of integrated bids for construction of Zojila Tunnel and its approach roads from Z-Morh Tunnel to Zojila Tunnel. Details of subject work are as below:
