Construction and upgradation of existing road to 2 lane with paved Item No.1. shoulder from Km 399.00 to Km 430.00 of Karanprayag to Chamoli (excluding Km 420.250 to Km 420.500 and Km 423.300 to Km 423.650) of NH-07 under Chardham Pariyojana on EPC mode in the State of Uttarakhand- Extension of Time (EoT) for III<sup>rd</sup> Milestone of Schedule-J - reg.

The Executive Committee deliberated the agenda and approved the Decision: EOT for shifting of III<sup>rd</sup> Milestone of Schedule-J for 180 days upto 10.09.2020 without any financial implication to the Authority.

Item No. 2. Construction of valley side slope stabilisation treatment including drainage, cross-drainage work and pavement in Dharasu-Gangotri road from Km 123.080 to Km 123.970 of NH-34 and stabilisation of dumping zone in the State of Uttarakhand- Extension of Time (EOT) of 40 days for Milestone-III and IV of Schedule-J- reg.
